**C Random Sampling and Extrapolation**

Join us for an interactive session, where you will learn how a random sample is developed here at CBH through a hands-on exercise utilizing Rat-Stats software, which is used not only by CBH, but other monitoring agencies including the Office of Inspector General (OIG) and Centers for Medicare and Medicaid Services (CMS) in their development of audit samples. We will take you through the process step-by-step, and discuss how a statistically valid random sample can be used in different types of auditing and monitoring practices including self-audits and extrapolation audits.
